

I) DEFINITIONS

Hyphen Mobility/Us/We: Means HMF Courtage S.A.S. You/Your/Referrer: Means the person that refers. Friend/Friends/Referred: Means the person referred. Referral Premium: Amount paid by us to the referrer and to the referred.

II) GENERAL TERMS AND CONDITIONS

1) Eligibility

- 1-1 Eligibility of referrer
- To be "Eligible," a referrer must:
- Be at least 18 years old.
- 1-2 Eligibility of the referred
- To be "Eligible," a referred must:
- Be at least 18 years old.
- Be a legal resident, non-resident of the United States of America or a person that plans to expatriate himself legally to the United States of America.
- 1-3 No part of this referral program is directed to persons under the age of 18. If you are under 18 years, you can NOT participate in this program at any time or in any manner.

2) Description of the Referred Program

4) Duration of the Referral Program

From June 15th, 2023, to December 31st, 2023



5) Payment of the Referral Premium

- 5-1 Payment of the referral premium is done once to the referred and the referred.
- 5-2 Referral premium is paid to the referrer and the referred in US dollars to a U.S. account by ACH payment.
- 5-3 Once the enrollment of your friend is approved by the insurer and the premium is paid, you and your friend will receive the one hundred (\$100) USD, ten (10) business days after the effective date of your friend's health insurance policy.
- 5-4 Referral premium is not recurrent at the moment of the renewal date.

6) Applicable Law; Arbitration; Class Waiver; and Waiver of Jury Trial

Any and all disputes, claims and causes of action arising out of or related to this referral program or any reward or other prize awarded pursuant to the referral program or to this agreement shall be resolved In Paris, under the French law (without reference to its conflicts of laws principles).
